

# Required Training Courses to be Taken by Provider Staff










# **Currently Required Courses**

9


4

# **Proposed Required Courses**



6 primary courses to be standardized
4 secondary courses to be standardized
3 courses that APD will define what organizations can provide trainer certification
13 courses to be standardized

#### 1 new course

4 courses will continue to be approved by C/O staff
