

#### **National Core Indicators**

- Launched in 1997 with 6 participating states
- Currently 36 states and 22 sub-state regions and counties
- Unparalleled 15-year database on over 12,000 individuals ~ 20,000 (including CA)
- Administration on Intellectual and Developmental Disabilities recently provided funding to expand the effort nationally to all 50 states
- Collaboration between NASDDDS HSRI participating state DD agencies

#### **NCI** Premise

- Improving performance starts with measuring performance – if you don't measure it, there is no guarantee that it will happen.
- NCI helps states to measure performance:
  - Over time (change from baseline)
  - Against multi-state benchmarks (our performance compared to performance elsewhere)
- Information is power

#### What are the NCI data sources?

- Adult Consumer Quality of Life Survey
  - Face to face interview
  - Random sample (minimum 400)
  - Adults only (18 years of age and up)
- Family and Guardian Mail Surveys
  - Adult Family Survey (at home, 18+)
  - Family Guardian Survey (out-of-home)
  - Children Family Survey (at home, <18)</li>
- State reporting on incidents, staff turnover, mortality





# **History of NCI in Florida**

- Started collecting NCI data in 2009-10
- Adult consumer survey data collected by Delmarva staff as part of the individual reviews
- Family and guardian mail survey data
- Valid and reliable sample of people receiving services
- Used for quality improvement and reporting to Centers for Medicare and Medicaid Services (CMS)





Demographic Information 2011-12




# **Average Age**








# **Ethnicity: Spanish/Latino/Hispanic**








# **Level of Intellectual Disability**














# Work and Day Activity 2011-12

People have support to find and maintain community integrated employment






### **Bi-Weekly Hours Worked**








### **Bi-Weekly Gross Wages**








#### **Receives Benefits at Work**

# **Self Directing Individuals**

#### 2010

- 8% (N=98) Florida
- 6% NCI Average
- Out of 1,230 respondents

#### 2011-12

- 19% (N=219) Florida
- 7% NCI Average
- Out of 1,155 respondents

Does someone talk with you about your budget and the services you can get?	79%	71%
Is there someone who helps you decide how to use your budget/services?	98%	89%
Can you make changes to your budget/services if you need?	86%	80%
Do you need more help deciding how to use your budget services?	59%	31%
Do you get information about how much money is left in your budget/services?	84%	80%
If yes, is the information easy to understand?	55%	70%



Hearing screening in past 5 years	49% v 61%	45% v 67%
Flu vaccination in past year	46% v 75%	48% v 77%



Colorectal screening for women and men 50 years and above in past year	5% v 9%	16% v 19%
Women over 40 had mammogram screening in past 2 years	29% v 43%	75% v 79%
Women over 18 had Pap screening in past 3 years	47% v 49%	64% v 71%
Men over 50 had PSA test in past year	12% v 23%	53% v 56%





People are satisfied with the services and supports they receive




### Satisfaction

# **NCI Data Tells Us...**

- Substantially more people living with families in Florida than nationally
- Fewer people with dual MH/ID diagnoses
- Psychotropic drug use up significantly in one year
- Most preventive health care improving substantial progress in colorectal screenings, mammograms, PSA tests
- More self directing individuals in FL than nationally
- Loneliness and employment flat-lined or getting worse
- Improvement in rights, privacy, & self advocacy opportunities
- A much larger percentage of people in FL are not getting the services they need
