#### Notes:

Today, John and I did research on the Internet, we read through the newspaper, we reviewed the phone book and made phone calls in order to gather information on types of dance classes or clubs in the community, cost, days and times of classes and locations. The following information is what we gathered:

- 1. Disco dance club located at 890 Gulf to Bay Drive in Hollywood open Friday and Saturday nights only from 7pm until 2am. Typically, people who enjoy disco music come in and dance at the club. Cover charge is \$10.00 to enter and drinks (alcohol and soda) is available for sale at the bar (prices vary).
- 2. YMCA on Fitness Rd. in Hollywood offers Salsa Dance class on Tuesday nights cost is \$15.00 per class start time is 7:30 pm to 8:30 pm.
- 3. Country line dance class is offered at the Country club on Country Club Blvd. in Hollywood from 8pm till midnight on Thursdays, Fridays, Saturdays and Sundays.

The information was all written down for John. We reviewed the information collected. Since the Salsa classes interfere with his favorite show we agreed to look into other possible options next time he works on his goal. We will continue to gather information.

Time in and out: 4:00-5:00 (4qh)

### Notes:

Today, John and I spent time looking for other possible Salsa classes in the community. We were able to locate a class at Sells Dance Studio on St. Rd. 43 in Hollywood Hills. The class cost is \$20.00 per class and they offer the classes at 7pm on Mondays, Tuesdays, Thursdays and Saturday at 10am. John said he likes to sleep in on Saturdays but would like to try this class on a Monday or Thursday night. John added this information to his list of possible places. We discussed the fact that the cost is more then the last class we looked into. We agreed to continue to look but John said he would like to take the class even if we don't find another class that is cheaper. We also talked about safety when going out into the community and the types of environments he may be in (dance club, dance studio, YMCA, Country club). We talked about not being "flashy" with money and possible consequences (ie. Possibility of being robbed). We talked about the importance of keeping his money safe in his wallet and to put his money in his wallet immediately after a purchase. We also talked about stranger danger and not accepting rides from strangers. John understands this information but often will brag to people about his money. The possible consequences of talking to strangers was reviewed with John. John understands stranger danger but does not always practice this because he

tends to be so friendly with everyone he meets. We will continue to work on these safety topics.

1-19-08

Time in and out: 3:15-3:45 (2qh)

Today John and I met to work on researching other possible places for Salsa dancing so we can compare cost, times and days of the weeks and location. After showing John how to research this information through the Internet and reviewing the local paper and phone book we were able to find the following information:

- Salsa Time Studio located on Broad Street in Valley Stream. Cost is \$15.00.
  Days and times for class are as follows: 7:00 on Monday, Tuesday and Friday nights.
- 2. Recreation Center located on Main Street in Valley Stream. Cost is \$14.00 per class. Classes are only offered on Saturdays at 10:00 a.m and again at 2 p.m.

John and I compared the prices, locations, times and days of the week of each class to see which would work best according to his preferences, routine and finances. Although the Salsa class located in Hollywood Hills is more expensive John liked the times and days offered and the fact that it was closer to his home. I pointed out to him that he would probably have to pay more money for transportation if he chooses the less expensive dance class because it is located further away and that it may not be worth it. I wrote everything down on paper for John so that I can show him the comparison. John said that he would like to sign up for the Monday night class at Hollywood Hills. We agreed to work on this the next time we meet. I offered the option of going and observing a class first, however, John is interested in attending the class. He also indicated that he may want to try some of the other types of dancing we talked about as well. While talking to John this afternoon, he asked me if he can use his money to buy a model airplane to work on at home. I used this opportunity to teach John about the right to spend his money as he chooses.

1-26-08

Time in and out: 4:00-4:30 (2gh)

Today, John and I talked about what to say when placing the call to the dance studio to sign up for his Salsa Dance class at Sells studio. John was nervous so we talked about using a speaker phone so that I can listen in and assist him if he needs help. I asked John to give me a cue by looking at me to let me know when he needs my assistance. John agreed and used the cue to let me know when my assistance was needed. John placed the call and scheduled to attend a class in mid February (Monday 2-16-08 at 7p.m.). After placing the call, John was so pleased and excited. I expressed to him how proud I was of him and that he did a wonderful job talking on the phone to schedule his class. We talked about the next step to work on, which would be budgeting his money and arranging transportation. We talked about the option of staff transporting for the first few classes until John is settled in and comfortable with attending the class and then exploring other possible options (public bus, taxi, friend or family transporting, etc.) John and I agreed to work on budgeting and arranging transportation next month.
