

NCI Guardian Status Tracking

All NCI States 2013-14

Adults with I/DD receiving services across NCI states:

- No guardian 50%
- Limited guardian 7%
- Full guardian 43%
- Don't know 2%

Florida 2013-14

Adults with I/DD receiving services in Florida:

- No guardian 70%
- Limited guardian 8%
- Full guardian 20%
- Don't know 2%

Can be alone with friends or visitors at home	81%	75%	71%
People ask before entering home	91%	89%	88%
Uses phone or internet without restriction	92%	90%	87%

Choice – Made decision or had some input into decision			
Home	62%	46%	41%
Roommates	54%	42%	35%
Staff (day & residential)	69%	64%	60%
Daily schedule	90%	79%	77%
What to buy	93%	83%	81%
